No, this is not just another boring bureaucratic shift. This will hit us where it hurts most –our right to be represented in local government at a time when Greenwich amenity is under real threat. The GCA has an exciting proposal to put to the community and we must act quickly -

FORCED COUNCIL AMALGAMATIONS - IS A MERGER WITH RYDE AND HUNTERS HILL THE RIGHT FIT? WE SAY "NO"

The GCA opposes forced local government amalgamations. This was affirmed at our meeting in February.

But the NSW government is giving every indication that they are going ahead regardless, and Lane Cove will be forced into an amalgamation with Hunters Hill and Ryde. This will mean that Greenwich will become a remote part of a much larger municipality, with offices headquartered in Ryde and our ability to select our own representatives very unclear.

Our previous newsletters have highlighted the shambolic and uncoordinated development of St Leonards and adjacent precincts, due largely to control being in the hands of three

separate councils. This development has placed great strain on the infrastructure of East Ward, particularly Greenwich, and will only get worse. The number of demountable classrooms in Greenwich Public School is but one example (see photo). A merger with Hunters Hill and Ryde will further expose East Ward residents to impacts of large scale development approved by councils in which they are not represented. It is critical for the planning of St Leonards that the area be managed by one council, and that East Ward residents have a voice. Recent NSW Government actions demonstrate its determination to push ahead with forced amalgamations. The GCA committee has responded to this urgency and we resolved at a specially convened meeting to seek new partnerships which would allow East Ward residents the best possible chance of having a say in developments so close to home and that affect us so dramatically.

Therefore, the GCA committee is proposing that East Ward be included in a future local government area that includes the St Leonards precinct and adjacent areas. We will be asking the community to support us in this course of action and committee representatives will be in evidence throughout the community in the next two weeks seeking this support.

The decision we have taken derives from our need to ensure, as far as possible, that forced amalgamation will not leave us on the edge of a new local government area with little or no ability to have input into developments that impact our part of Lane Cove so significantly. It is vital that residents attend the meeting next Wednesday as the NSW Government is moving very quickly.

CYCLING UPDATE

Following the request from parents at Greenwich Public School who wish to accompany their children to school while teaching them safe cycling skills and etiquette, Council recently installed a 13 - scooter / 4 - bicycle rack outside the Greenwich Rd Infant School campus, directly opposite the shops (see photo).



Many parents are unaware that children up to 12 years of age and accompanying adults are legally allowed to ride on footpaths.

Last year Council upgraded the shared user pathway (SUP) through the bushland from Greendale Street to the Smoothy Park Bridge. This is now safer for cyclists, prams and pedestrians. The footpath along River Road from Greenwich Road to St Vincents Street was also widened to a SUP.

In January a large rock fell on River Road footpath on the narrow cliff section between the golf course and the rear entrance of Greenwich Public School. Council's Bicycle Advisory Committee, supported by Council, Anthony Roberts, the GCA and Greenwich P & C lobbied Duncan Gay, the Roads Minister, for this footpath to be made safe and widened to SUP standard. Council commissioned GeoTech Reports and will soon stabilise sections deemed most hazardous.

The EPA has responded to our detailed submission on the licence review for the Gore Bay terminal. The Gore Bay Terminal Sub Committee has yet to fully digest the response but at first glance it was disappointing – petrol storage will remain an option. Release of the Human Health Risk Assessment continues to be blocked by Viva Energy.
