6. Report on Activities of the Association

- (a) Presidents Report no written report, see later items. However 2 items specifically.
 - Greaton and Top Spring have submitted for re-zoning review with Sydney North Planning Panel following Council's rejection.
 - Dept of Planning currently very disrupted (and slow to respond) due to staff transfers and reorganisation.

(b) Treasurers Report

Cash status – Year to date loss of \$119. Due to need for more newsletters to be produced, final forecast will be \$600-\$700 loss by the end of the year (slightly improved forecast).

Note: Cash reserve of \$12,000 still on deposit, available if needed.

7. Reports of Sub Committees

(a) Greenwich Baths

Nothing to report

(b) Gore Bay Terminal

Air Pollution - still pushing for boundary monitors.

Noise Pollution – Viva required to continuously monitor. One elderly Wondakiah resident concerned about increased noise/vibration but no other residents have expressed concern. Possibly due to Metro tunnel works under the harbour.

(c) Bicycle Plan (Draft)

Don Murchison has reviewed Council's draft and the GCA has made detailed comments back to Council.

Now awaiting Council's response.

8. Councillors Reports

See earlier comments – no Councillors able to attend. However the meeting acknowledged Councillor Zbik's very positive input (noting that he does not represent East Ward).

9. Notified Business

(a) State Significant Development Applications Greenwich Hospital

- Over 200 resident submissions
- Noted use of site changing from just medical hospital to include residential.
- Residents' concerns included mass of buildings, overshadowing, loss of trees, change of use.
- Proponent asked to review.
- SSD therefore bypasses Council.
- Not sure whether further submissions will be needed in view of proponent's reviewed design or do original submissions still hold?
- GCA acknowledged the input of Doug Stewart (re this proposal and many others).

Doug was an Architect and a very active community member, who sadly passed away some 6 weeks ago.

International Chinese School

- Spoken to by Valerie Reynolds a concerned local resident.
- SSD Willoughby Council bypassed.
- Up to 210 students proposed
- · Access via Old Cemetery central road
- No covered external space proposed
- Wants to use public park playground and Gore Hill Oval as play space
- Deadline for submissions 24th October

- Note empty shell building (repair and extension) already underway
- Need sufficient objections to get referral to an IPC
- GCA so busy with SLS etc. that it does not have the resources to lead the process, but will make a submission based upon it being an inappropriate development i.e. specifically inappropriate location and lack of external space.
 M.S. has already written to the group 'Friends of Gore Hill'.

(b) Draft Local Strategic Planning Statement

- GCA concerned that within this statement SLS (unchanged) is the sole solution to Lane Cove LGA's future housing needs
- Noted all Councils are required to produce an LSPS
- Also noted all Councils are required to produce a Housing Strategy document
- Lane Cove Council has not done this
- Agreed residents should write to Council (copied to Dept of Planning) with their concerns. (Submissions close tomorrow 17th October 2019)
- M.S. will email out draft submission from GCA for review before finalising

(c) Draft Community Participation Plan

Comments due by 13th November

(d) Planning Proposals

- Andrew Zbik finally has his motion accepted at Council, for Council to request the Minister to impose a temporary moratorium on the acceptance of future planning Proposals

 community cannot understand why it took so long for Councillors to agree to this motion
- **Top Springs and Greaton** had Planning Proposals knocked back by Council.

NSPP now to decide – hearing dates Greaton 24th Oct, Top Springs 6th Nov

Public not allowed to attend. Council is allowed to and will address NSPP.

GCA and others should write to DOP (cc to Council) to put the case against these proposals.

Contact at DoP is Ms Amanda Harvey

Telstra Site

DoP recommending change to zoning to mixed use so that a combined commercial/residential development could occur (increased viability).

Grocon (developer) looking for 58 storeys of residential. Council is against the residential proposal even though it has recently approved a number of similar developments.

SLS Update

M.S. brought the meeting up to date with current status. Council wants DoP to lead the design, however DoP will not do this, as it is not their role and it is a Council developed scheme. GCA has asked DoP for an update.

General discussion on the way forward.

General frustration with response to GIPA by Council such that when pushed a number of times the information having been requested (and potentially paid for) is suddenly released for free into the public domain. This has now occurred a number of times.

Animated discussions from many attendees about the way forward and respective inputs to date (and projected into the future) specifically by the Mayor and GM.

David Astridge explained the need for a new Masterplan and the discussions he has been having with the Mayor on this matter. Suggested resultant way forward as follows

- Encourage residents to address Councillors prior Council meetings
- Develop a petition (getting as many signatures as possible) and send to DoP
- Continue to discuss concerns and the way forward with Councillors and particularly with the Mayor.
