#### YOUR GCA

### PLAZA UPGRADE

It is pleasing to see that the Council has heard the vehemence of the opposition to the proposed Lane Cove Plaza Phase 2 works and modified their plans accordingly. While the amended plans will retain some of the trees and do away with the balustrades, the horizontal glass roof which was opposed due to aesthetic and practical problems still remains.

There is also concern as to the potential cost of this upgrade, which has now risen to \$5.1 million. It could be queried if the money would be better spent on projects considered more urgent, such as bicycle facilities.

One of Greenwich's best kept secrets is the Majorie Propsting Library, tucked away modestly next to the Community Centre in Greenwich Rd. # SHELL

Because Shell is situated very closely to its residential neighbours of Greenwich and Gore Bay areas, an ongoing concern of the GCA is that Shell adopt world's best practice in their operations in the interests of community health and safety.

To that end the GCA and other interested community groups ask for transparency of operations, full consultation with residents and the highest level of compliance with regulatory authorities. The GCA is also aware of its important role in acting as a forum for those in the community who are interested in these matters but who lack the time and resources necessary to examine the issues in depth.

### SUBCOMMITTEE REPORT

Subject to approval, Royal Dutch Shell has agreed to sell its entire shareholding in Shell Australia to global oil trader Vitol in a consortium with the Abu Dhabi Investment Council. This means that all of Shell's petrol stations, fuel storage operations (including Gore Bay Terminal), pipelines and refineries will be controlled by a new entity. The Shell name will continue for a term to be announced but a new (and unknown in the Australian context) board will be making decisions.

This transaction is happening when public exhibition of an application to the Department of Planning together with an Environmental Impact Statement (EIS) for major works at Gore Bay is imminent. These major works include: removal of redundant tanks, covering one of the large tanks with a geodesic dome to facilitate storage of jet fuel (kerosene), and upgrading the current control systems to increase efficiency and safety.

Given the potential change of Shell ownership at Gore Bay, it is vital that the

community stay on top of any concerns about operations and the Department of Planning impose strict conditions to protect health and safety if approval is granted for the Shell application. One major concern is the potential to store petrol at Gore Bay. Shell is permitted to store petrol on site under its current EPA licence, berthed vessels hold large quantities of petrol, and the refurbished tanks will also have that capacity. Current Shell management has assured us that petrol storage is not planned; however, it is a topic that must be examined further in light of the planned changes.

The time frame for the public submissions is likely to be between 30 and 60 days, very little time for the community to understand and comment upon what will run to at least 1000 pages of complex technical data. Lane Cove Council has agreed to host an information session about the application. This will, of necessity, be brief and cannot hope to explore fully the data in the documents and the implications for the community.

This is an urgent SOS for help from people with current technical skills in areas such as public health, risk assessment and petrol transport and transfer. You are needed to assist community members understand what they are reading so they can form their views on the application and make submissions.
