Bob Campbell Oval Update No. 3

Late yesterday Council officers removed approx 12 corflute "Say No to Synthetic" signs that had been sympathetically placed around the suburb. Some on stakes in the ground and some on lamp posts. The lamp post signs were tied on with string. Council officers also removed laminated "Save this Tree" signs at Bob Campbell Oval that were again tied with string to their trunks. (It is not widely appreciated but 8 fully grown trees in the car park - to make way for the the new car park - are destined for the chain saw.....)

Signs on private property appear to be acceptable so If any resident is happy to have a sign in their garden or on their fence please let me know. They can be delivered on a stake, with string attached or stand alone if that suits better.

I am happy to report that Community support for the GCA's position is both overwhelming and humbling. A synthetic pitch and all the problems it will bring is just not wanted by the community. A professionally built and maintained grass surface is the preferred option for active and passive recreation.
